SCALE OF CHARGES LANDLORDS:

PREMIUM MANAGEMENT SERVICE:

21% of rent collected (17.5% +vat) payable for each letting.

Example: If the monthly rental is £900pcm you will pay £189 inclusive of VAT

Plus set up fee £360 (£300 + vat)

FULL MANAGEMENT SERVICE:

14.40% of rent collected (12% +vat) payable for each letting.

Example: If the monthly rental is £900pcm you will pay £129.60 inclusive of VAT

Plus set up fee £360 (£300 + vat)

LET ONLY SERVICE:

60% of rent collected (50% + vat) payable for each letting.

Example: If the monthly rental is £900pcm you will pay £540 inclusive of VAT
